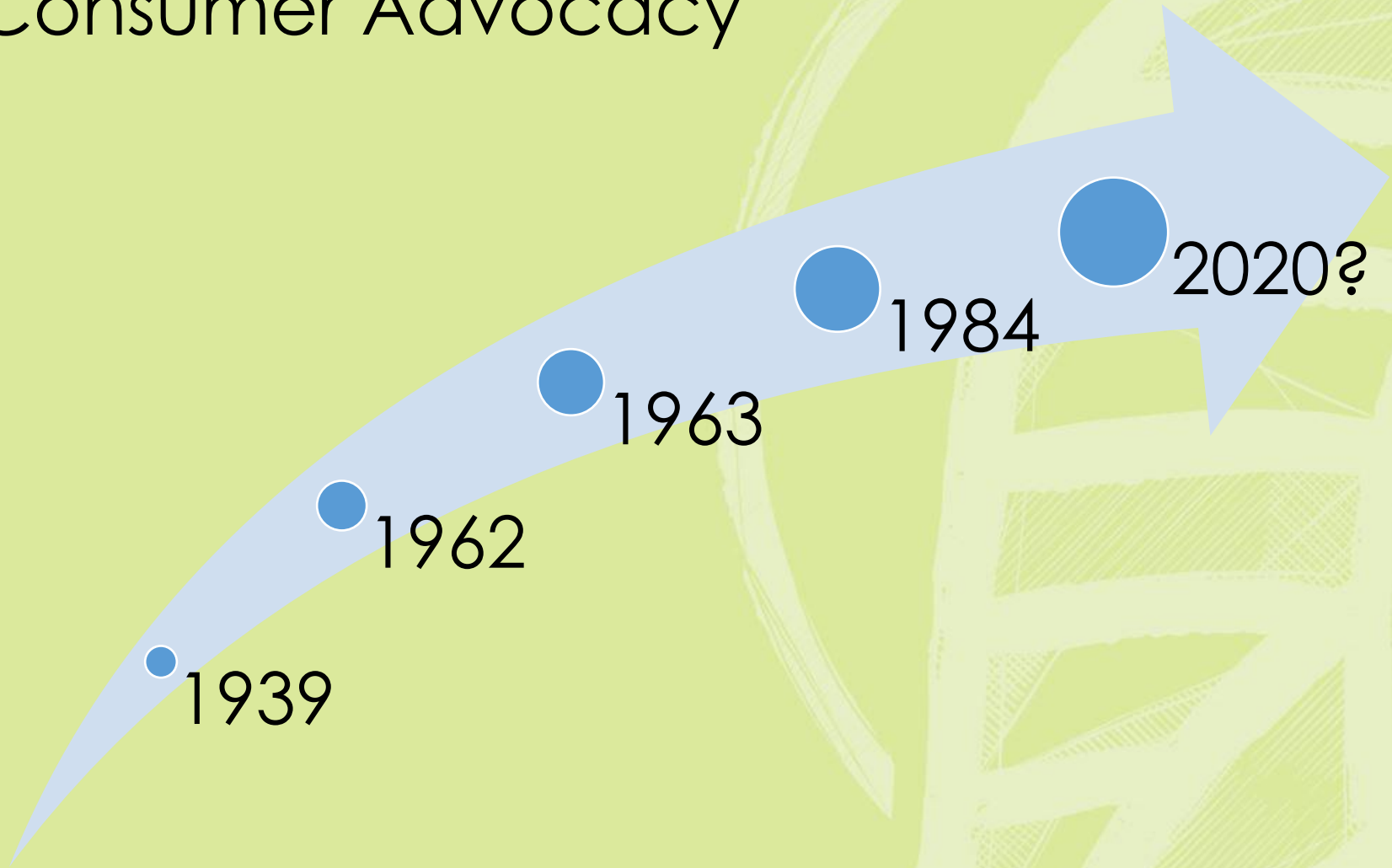

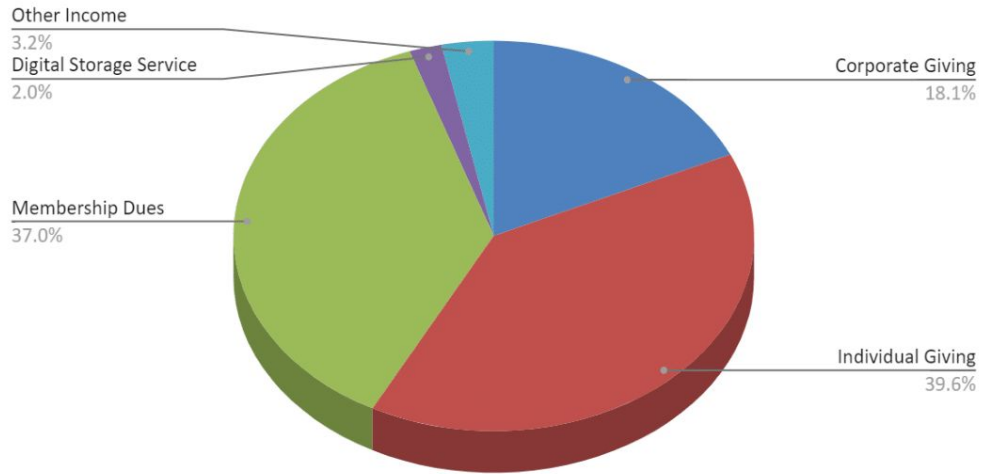

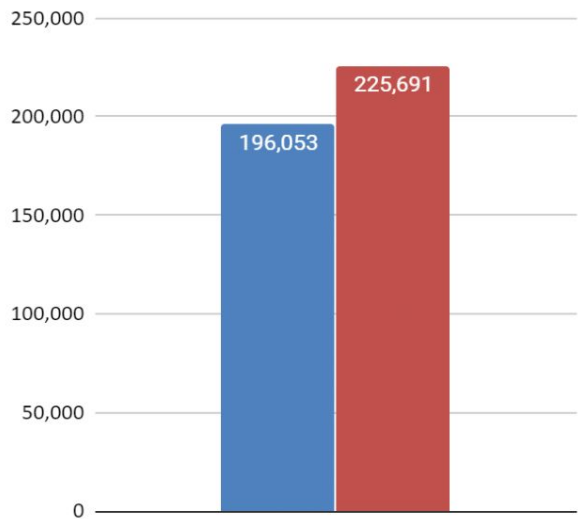
PMA 2019 Actual vs Budget INCOME



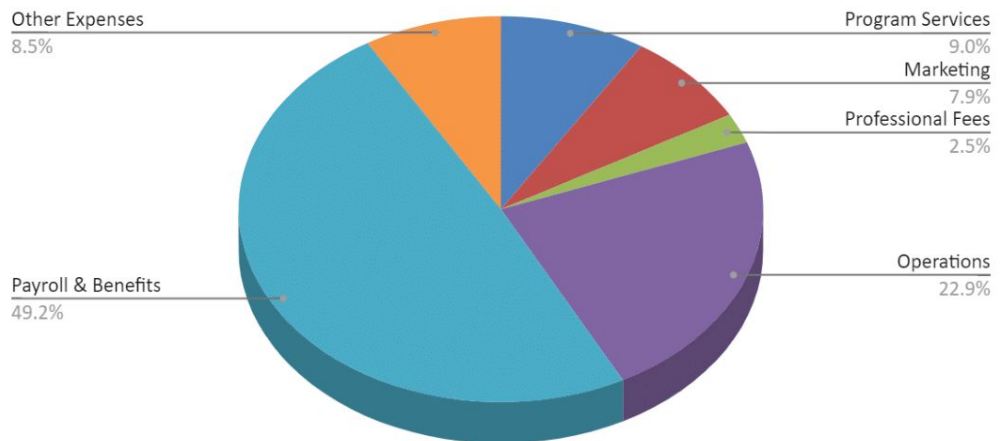
People's Memorial Association 2019 INCOME



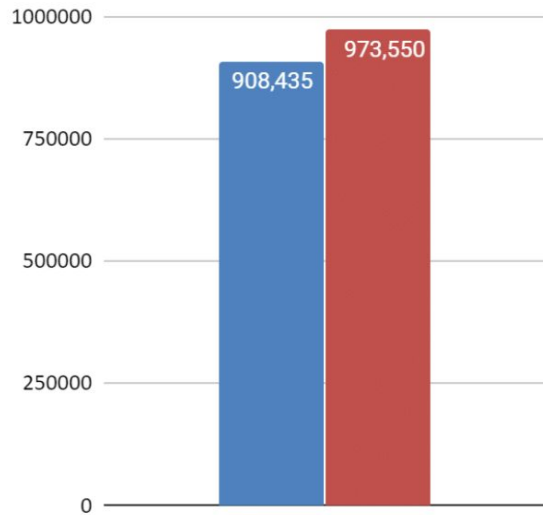
PMA 2019 Actual vs Budget EXPENSES



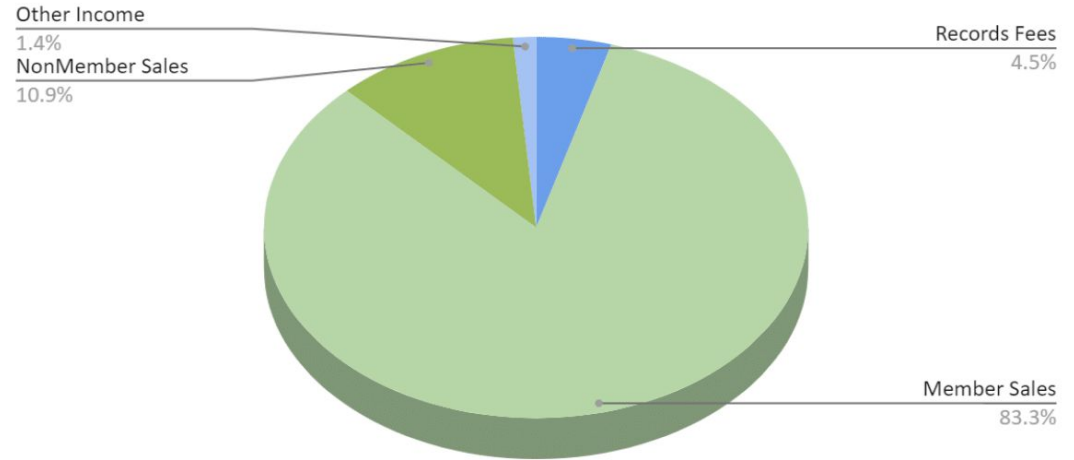

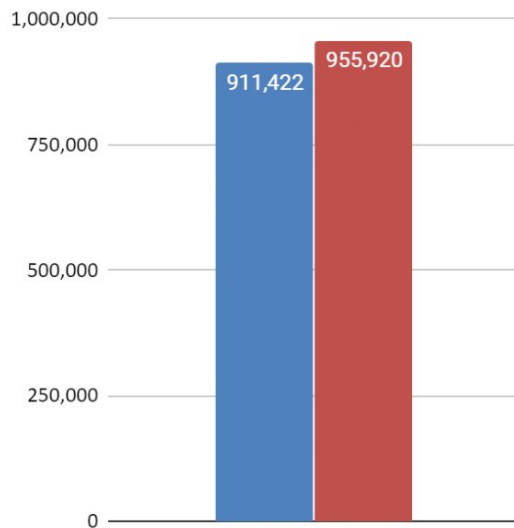

Actual vs Budget INCOME



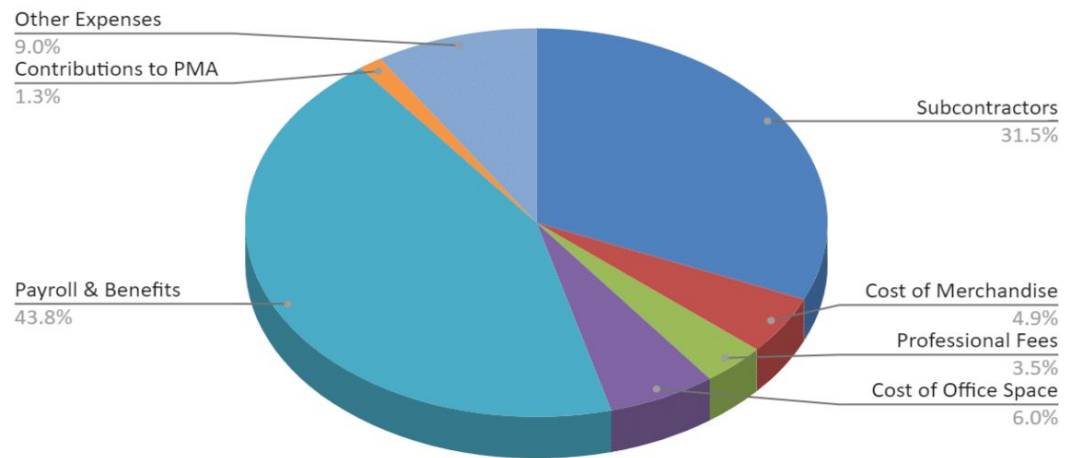

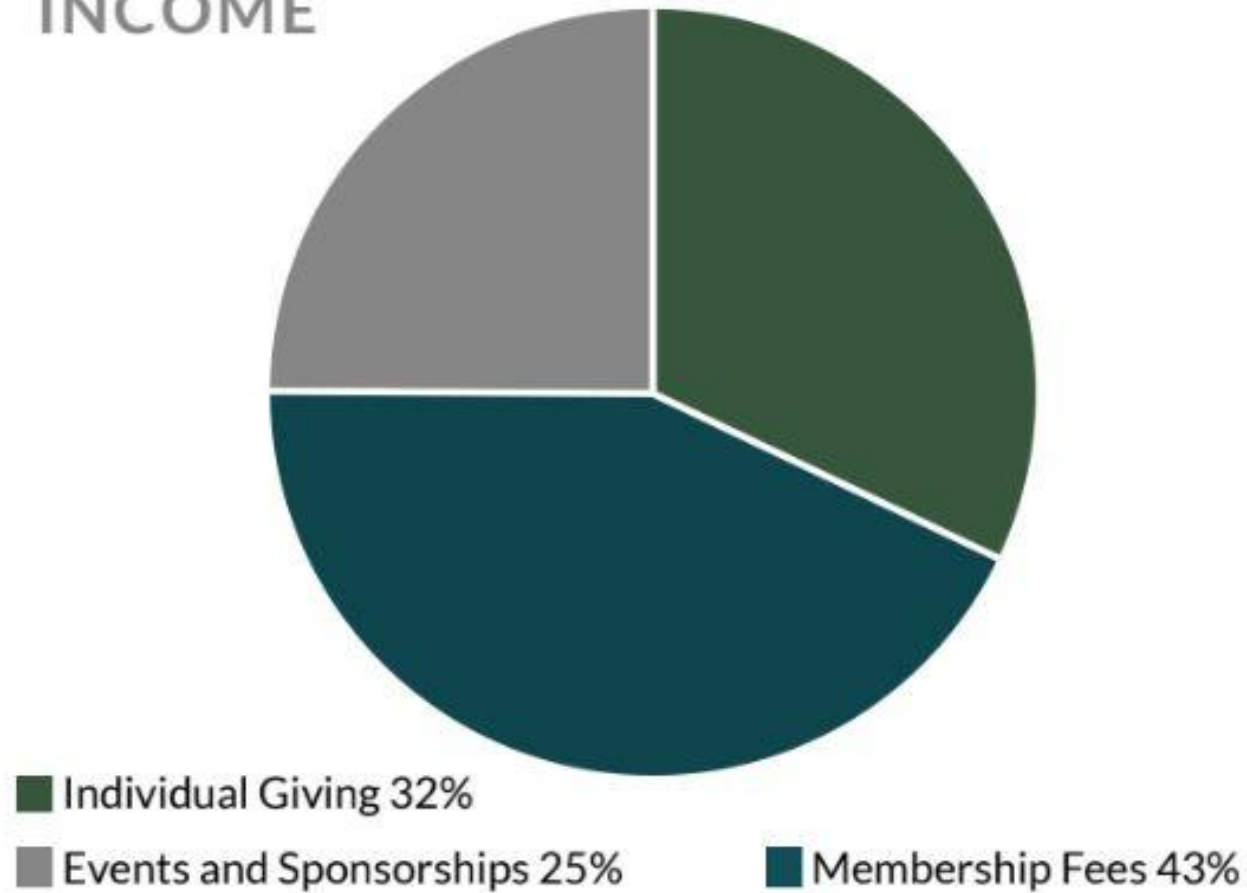
