2020 Funeral Home Price Survey

Cremation prices vary by over 745%. The average cost for Direct Cremation \$1,570 Ranges from \$495 to \$4,165.

Burial prices vary by over 400%. The average price of Direct Burial \$2,924 Ranges from \$1,045 to \$5,290.

Complete Funeral Service averages \$5071 Ranges \$2,045 and as high as \$11,100.
