What is Probate?

It is a court-supervised process of settling a dead person's (decedent) estate, basically settling debts and transferring assets. The Superior Court gives the personal representative (aka executor) the power to settle the estate by issuing that person Letters Testamentary, which show the rest of the world that the executor has the power to deal with the decedent's estate. The executor is then charged with gathering all the decedent's probate assets, notifying and paying the deceased's creditors, filing tax returns, paying taxes and ultimately distributing the assets to the decedent's beneficiaries under his will (if any) or the Washington laws of intestacy (no will). Probate is required when a decedent dies owning probate assets, which are basically assets that don't pass via contract (such as a community property agreement, a trust agreement or a beneficiary designation) or automatically by law (such as through joint tenancy with right of survivorship). Probate may not be required if the decedent's personal property (cars, household items and bank accounts) is valued at less than \$100,000 and left no real estate.
